Arts Education

Support for Arts Education

Lifelong arts learning is a top priority for state arts agencies (SAAs). Arts education in schools fosters young imaginations, addresses core academic standards and promotes the critical thinking and creativity skills essential to a 21st-century workforce. State arts agencies support in-school, after-school and out-of-school programs; early childhood arts learning; arts in higher education; and adult/senior programs through **grant making, services, research, and partnerships and collaborations.**

Grant Funding for Arts Education

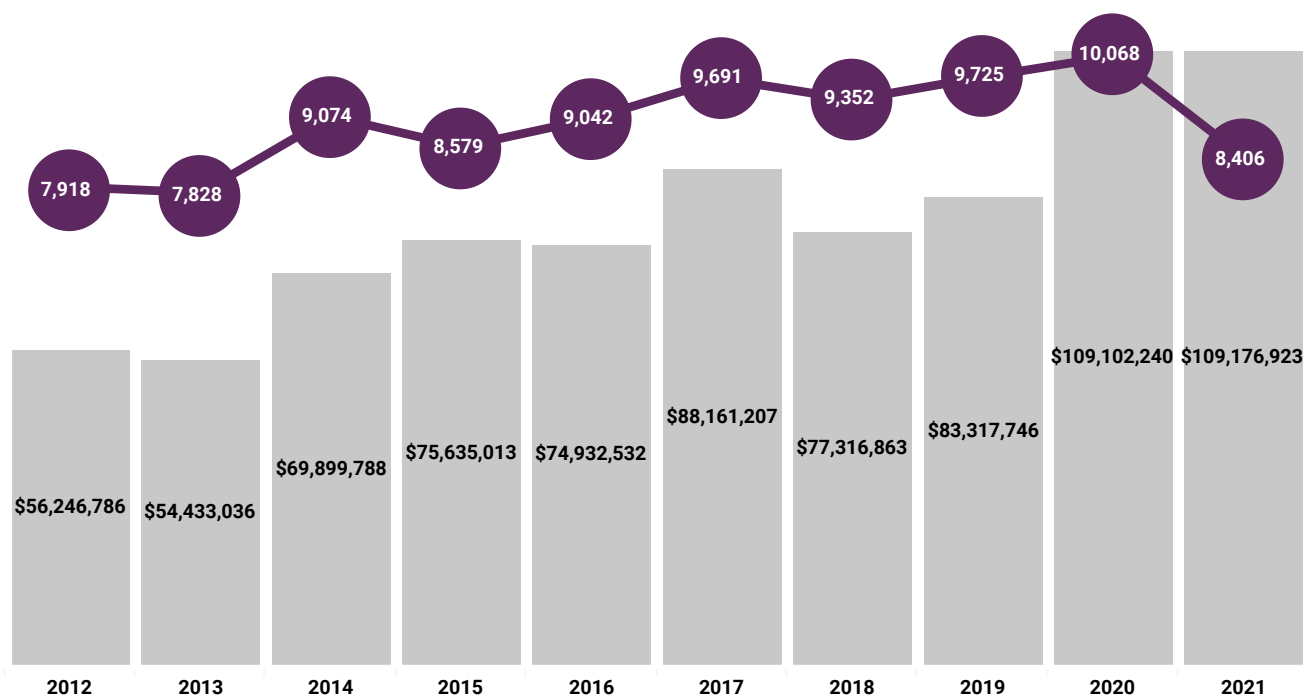
SAAs invest more than \$100 million in arts education. Arts education grants comprise the largest share of overall SAA grants awarded, at 24%. They support performances, exhibitions, residencies (school and nonschool), instruction and curriculum development. Arts education grants also support the design of assessment and evaluation tools and fund professional development programs. About 28% of arts education grants goes toward flexible organization operating support—dollars that are difficult to acquire through other grant programs.

Arts Education Grant Making 10-Year Trend

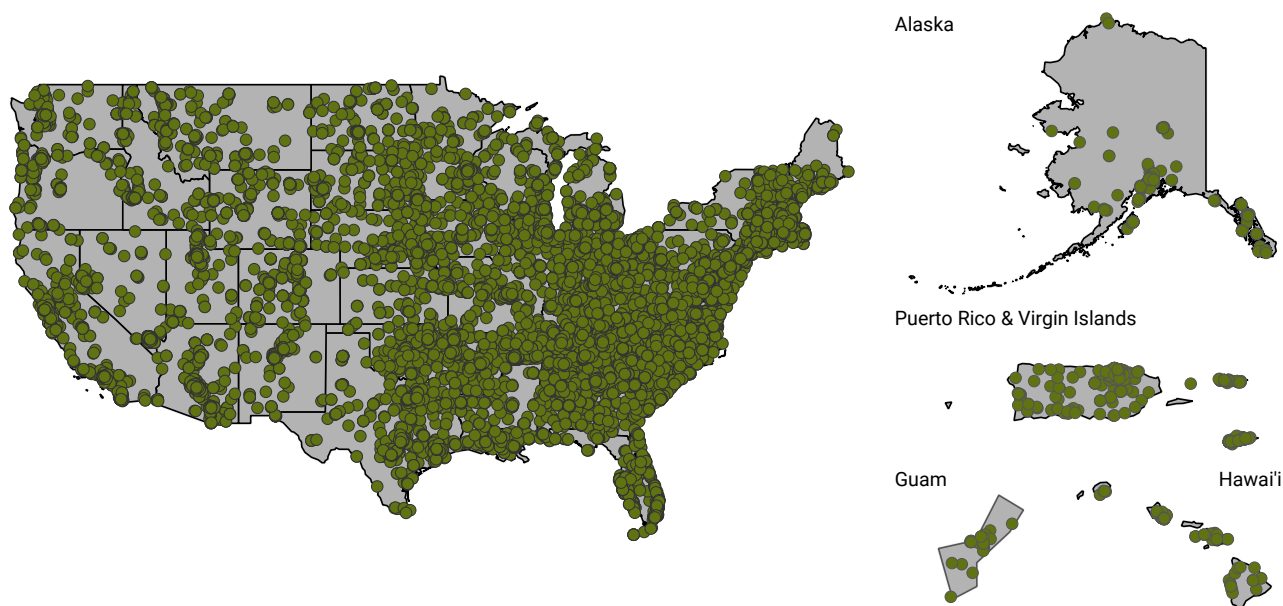

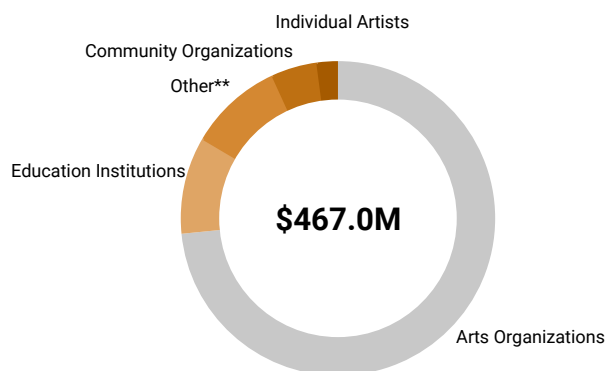
Services: SAAs provide extensive training and services to complement grant programs. Services geared toward teaching arts organizations focus on classroom management, resident teaching-artist training, and how arts can integrate with other core subjects. Other services are geared toward individual artists servicing educational settings.

Research: SAAs lead state level efforts to assess and monitor the status and condition of K-12 arts education by encouraging high-quality, evidence based research; ensuring that research is designed to inform policy; and communicating research results to decision makers and the public. This work is often done in partnership.

Partnerships and collaborations: SAAs cultivate program and policy collaborations with different partners including state departments of education, statewide arts education networks, statewide arts advocacy organizations, after-school alliances, institutions of higher education and teacher associations.

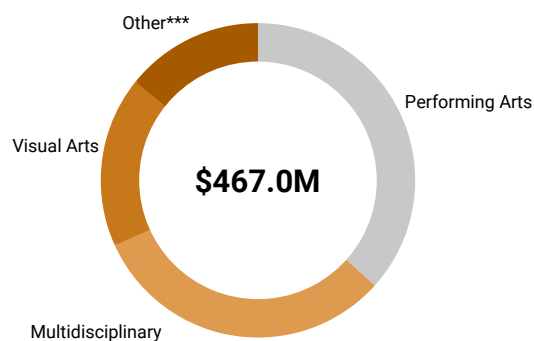
What Do Arts Education Grants Support?
